Prior to formally opening the meeting, Cllr Richard Levell addressed the meeting as the retiring Mayor and presented cheques to representatives from his chosen charities, East Northamptonshire First Responders and Raunds Foodbank.

Well, another year has flown by; so many Saturdays have been and gone, and here we are again at an Annual Meeting.

But it has been an interesting year, starting with the Queen's Platinum Jubilee last June and ending with the Coronation a few days ago. While as a Council we did a lot for the Jubilee, for the Coronation weekend we let people do their own thing. Magda and I watched the Coronation on Saturday, attended a street party in our road on Sunday and yesterday we were in Gumster for a splendid lunch. We had fun and I hope everybody else did.

The Council had planned to hold the Mayor's Show in September but sadly this had to be cancelled because of the death of Her Majesty Queen Elizabeth II. But panic not, this year's show is in a fortnight's time on 21 May and will have a royal theme, as will the Saturday market the day before.

I don't want to repeat the summary of achievements in the year that I spoke about at the Town Assembly a couple of weeks ago, except to say that we have achieved a lot, the result of the hard work put in by the Committee Chairmen and the Council staff. We have had a few comings and goings among staff members this year, but Nicola and Jane, who are looking after us this evening, represent an element of continuity, while Steve Tucker has made a great impact, positive I should add, since he joined us last autumn. On behalf of the Councillors and the residents of the town, I should like to thank them and the rest of the staff for everything that they have done throughout the year.

Being the Mayor this year has been less time-consuming than in my previous terms, as people still seem to be hesitant to mix as much as they did before the pandemic. Whereas I attended 180 events in the town and the county in 2018/19, this year I have been to under a 100. In particular, care homes, where I spent many happy hours last time, are still very cautious about admitting visitors – or maybe it's just me they've been avoiding. Either way, I hope that things continue to open up and get back to where we were before 2020.

I held a couple of fund-raising events. First was the Murder Mystery evening at Jesters Bistro back in August. The restaurant was filled to capacity and we were treated to a splendid meal. The second fund-raising event was a quiz in October which was attended by over 100 people.

Magda and I have been able to raise £4000 for my two chosen charities, and thank you to everyone who has supported us in this effort. As many of you are aware, the charities are the Raunds Foodbank and the East Northants First Responders.

As those of you who have been a Mayor will know, it's not a walk in the park – it's time-consuming and hard work, (and unpaid) and three times is enough. For now. Thank you for everyone's support during the year, not least my wife, Magda, whose year has also been turned upside down.
