The Returning Officer will, at the request of any elector, prepare a nomination paper for signature.
3. Nomination papers must be delivered by hand to the Returning Officer at Municipal Offices, Bowling Green Road, Kettering, NN15 7QX by no later than 4pm on 2 April 2025.
4. The times during which the Returning Officer will accept delivery of nomination papers are as follows:-

6. An informal check of nomination papers may be requested prior to formal submission. Nomination papers to be checked informally should be scanned as a pdf file and submitted by email to nominations@northnorthants.gov.uk by no later than 4pm on Tuesday 1 April 2025. Formal submission of nomination papers must be made by hand as detailed at points 3 and 4 above.
7. If any election is contested the poll will take place on Thursday 1 May 2025.
8. Applications to register to vote must reach the Electoral Registration Officer at Municipal Offices, Bowling Green Road, Kettering, NN15 7QX by 12 midnight on Friday 11 April 2025. Applications can be made online: <https://www.gov.uk/register-to-vote>.
9. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Municipal Offices, Bowling Green Road, Kettering, NN15 7QX by 5pm on Monday 14 April 2025. Apply online at www.gov.uk/apply-postal-vote.
10. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer at Municipal Offices, Bowling Green Road, Kettering, NN15
